



Trainee Programs allow international applicants to participate in a structured, work-based career advancement program or trainee opportunity offered by a U.S. host company. The Professional Trainee Programs offer opportunities for professional development, insight into American business practices and a greater understanding of American society, culture and life. This visa cannot be used as a temporary employment visa.

Who qualifies for Professional J1 Visa Trainee?

J-1 visa Trainee must be a foreign national: (1) Who has a degree or professional certificate from a foreign post-secondary academic institution and at least one year of prior related work experience in his or her occupational field outside the United States, or (2) Who has a minimum of five years of work experience in his or her occupational field outside the United States.

Program Services

- Global Mexico provides initial screening, selection, document gathering, English testing, initial orientation, receives and processes international payments, mediates between prospect and US Partner. Follows upon participants return to Mexico.
- Provides program sponsorship for J-1 visa Trainee Programs, and issues a Form DS-2019 for sponsored program applicants.
- Ensures that training programs expose participants to American methodologies, business practices and professional knowledge.
- Pre-screens host companies and ensures that every sponsored training program is in compliance with the U.S. State Department regulations and guidelines.
- Staff monitors each program from start to finish through periodic correspondence, site visits, and progress evaluations.
- Provides comprehensive sickness and accident insurance coverage in accordance with State Department's policy provisions.
- Assists participants in locating suitable housing.
- Offers arrival orientation guidance that helps participants understand local laws, customs and culture.
- Provides a 24-hour, toll-free program assistance hotline.

NOT PERMITTED FOR SPONSORSHIP: unskilled or casual labor positions, child care, elder care, clinical/patient care, positions that provide therapy or medication, sports or physical therapy, psychological counseling, nursing, dentistry, veterinary medicine, social work, speech therapy, early childhood education, positions provided by or facilitated through staffing or employment agencies.

Sponsorship Program – provides Trainee opportunities in the following occupational fields:

- Agriculture, Forestry, and Fishing
- Education, Social Sciences, Library Science
- Information Media and Communications
- Public Administration and Law
- Arts and Culture
- Hospitality and Tourism
- Management, Business, Commerce and Finance
- The Sciences, Engineering, Architecture, Mathematics, and Industrial Occupations

Each applicant is required to submit a complete application package. Application review will begin only after the receipt of completed application documents and program fee payment verification. Applicants who do not have a secured position in the U.S. may choose to secure a suitable training from currently available program options.

Cancellation / Visa Denial

Applicants who cancel their program or who are denied a visa are eligible to receive a refund of their program and insurance fees. In the event of visa denial, must be notified in writing no more than 5 business days after the visa denial and the original DS-7002 (Training Plan) must be mailed back to the office no more than 20 days after the denial. A cancellation charge due to visa denial of \$500 will apply. **There is no refund of fees if cancellation comes after arrival in the U.S.**
